Park Potomac in Montgomery County

Foulger Pratt's mixed-use development will break ground in October. Park Potomac will include 570,000 sf of office space of which 65,000 sf has been preleased to the law firm of Shulman Rogers Gandal Pordy and Ecker PA. Also included will be 145,000 sf of retail to include a Harris Teeter grocery, a hotel and convention center as well as a residential component.

Woodmore Towne Center in Prince Georges County

Conveniently located in Landover MD at the interchange of 495 and Rt. 202; this project to be developed by Petrie Ross will offer 820,000 sf of office, 700,000 of retail (Wegman's and Cosco are the lead retail tenants!) an abundance of residential as well as 2 hotel sites and a convention center site.

Jefferson Technology Park in Frederick County

With the potential to build up to 1 million square feet of office space this research and development park located at the intersection of I -70 and Rt.340 will also include 250,000 sf of retail, 200 residential units and a hotel/conference center.
