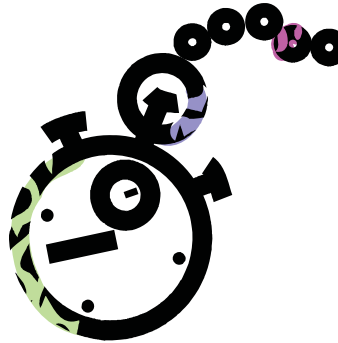


JULY CREW PROGRAM – SAVE THE DATE!
